Tuition Policy

1. Tuition is payable to Los Altos Christian Preschool in 10 monthly installments with the first installment billed in June and subsequent installments billed from September-May, and is based on an annual tuition rate.
2. Tuition is due to Los Altos Christian School by the first of each month. Tuition payment not received by the 10th of the month will result in a late penalty fee of 10% of the monthly tuition rate.
3. A tuition deposit of $\frac{1}{2}$ the monthly tuition rate is due at time of enrollment.
4. Students will not be permitted to attend class if tuition is more than 30 days delinquent.
5. Parents must meet the financial responsibilities promptly in order to maintain teacher salaries and school expenses.
6. All registration fees are non-refundable.
7. A \$25.00 service charge will be assessed for returned checks. Cash payments will be required if more than one check is returned by the bank due to insufficient funds.
8. Advanced written 30 days notice, is required for voluntary withdrawal from Los Altos Christian Preschool. If less than 30 days advanced written notice is given, tuition deposit will be forfeited. Parents will be responsible for tuition payment up to the final day of attendance when advanced written notice of withdrawal is given.
9. Enrollment at Los Altos Christian Preschool is considered a commitment for the full school year. Tuition will not be pro-rated for the month of voluntary withdrawal when less than 30 days written notice is given.
10. Illnesses, vacations and other absences, other than permanent withdrawal as specified above, are not deductible from tuition.
11. Any changes to your child's schedule from the original scheduling at the time of enrollment and registration will result in a \$50.00 change of service fee. All schedule changes must be accompanied by a signed agreement and require approval by the director prior to taking place. As schedule changes cause staffing changes, please choose your child's programming carefully upon enrollment.
