## Roadmap to School Reopening

In-person and On-Campus

Teach and reinforce washing hands, avoiding contact with one's eyes, nose, and mouth, and covering coughs and sneezes among students and staff.

- □ Teach students and remind staff to use tissue to wipe their nose and to cough/sneeze inside a tissue or their elbow.
- Students and staff should wash their hands frequently throughout the day, including before and after eating; after coughing or sneezing; after classes where they handle shared items, such as outside recreation, art, or shop; and before and after using the restroom.
- ☐ Students and staff should wash their hands for **20 seconds with soap**, **rubbing thoroughly after application**. Soap products marketed as "antimicrobial" are not necessary or recommended.
- I Staff will model and practice handwashing. For example, for lower grade levels, use bathroom time as an opportunity to reinforce healthy habits and monitor proper handwashing.
- Students and staff should use fragrance-free hand sanitizer when handwashing is not practicable. Sanitizer must be rubbed into hands until completely dry. Note: frequent handwashing is more effective than the use of hand sanitizers.
- □ Ethyl alcohol-based hand sanitizers are preferred and should be used when there is the potential of unsupervised use by children.
- ☐ **IsopropyI** hand sanitizers are more toxic when ingested or absorbed in skin.
- □ Do not use hand sanitizers that may contain **methanol** which can be hazardous when ingested or absorbed.



LACS will ensure adequate supplies to support healthy hygiene behaviors, including soap, tissues, no-touch trashcans, face coverings, and hand sanitizers with at least 60 percent ethyl alcohol for staff and children who can safely use hand sanitizer.

- LACS provides the following PPE:
  - Surgical masks
  - Gloves
- Staff and students will be highly encouraged to be immunized each autumn against influenza unless contraindicated by personal medical conditions, to help:
  - Protect the school community
  - Reduce demands on health care facilities
  - Decrease illnesses that cannot be readily distinguished from COVID19 and would therefore trigger extensive measures from the school and public health authorities. (See flyer)

#### **Handwashing & Other Hygiene Measures**

- □ Teach students how to properly, for at least 20 seconds, wash their hands. Use the training video below, and in-person modelling:

- ☐ The sharing of supplies and equipment among staff and students will be minimized to the extent feasible.
- ☐ Shared items will be **cleaned and disinfected** between uses.
- □ Students' contact with high-touch surfaces will be minimized to the extent feasible.
- ☐ Children under age 9 should only use hand sanitizer under adult supervision.

#### **Daily Handwashing/Sanitizing routines**

- ☐ Upon **entering** school buildings.
- After using the restroom.
- After playing outside and before returning to the classroom.
- Before and after eating. **Teachers must allow enough time** for handwashing/sanitizing before you drop your students off for lunch.
- After coughing or sneezing.
- □ Regular cleaning and disinfecting of frequently touched hard surfaces in your classrooms/office space.
- □ Sanitize student desks at least once a day. Students can be trained to clean their own desks. Gloves will be available for cleaning.

#### **Handwashing & Other Hygiene Measures**

- At least daily, and more frequently if feasible, staff and teachers will clean and disinfect frequently touched hard surfaces (e.g., tables, desks, chairs, door handles, light switches, phones, copy/fax machines, bathroom surfaces (toilets, countertops, faucets, drinking fountains, and playground equipment) and shared objects (toys, games, art supplies, books)
- Teachers must **schedule a daily cleaning** of their classrooms- focus on frequently touch surfaces.
- □ Admin and the facilities crew will disinfect commonly used hard surfaces daily. (See attached cleaning schedules)
- ☐ Three **mobile handwashing** stations has been purchased for the playground.

Food Services (School lunches will be suspended for the forseeable future- no microvawe will be available to warm up packed
---

All food items and choices will be fully <b>boxed/bagged</b> .
Packed lunches are encouraged.
No food can be <b>directly touched</b> by students-will be handed to students.
Students will eat in the gym, outside, or in classrooms.
Students eat within their cohorts, with physical distance -25ft between cohorts.
Students will be encouraged to wear shields while they eat.
Staggered start times for lunch.
Packaged cutlery, seasonings, sauces and napkins in single serve packages.
Markings on ground to prevent crowding.
No sharing of supplies and/or lunches among students.
All students must wash/disinfect hands before and after meals.
Students will <b>line up and eat</b> within their cohorts
Tables and chairs will be washed/disinfected after each group
Traffic flow will be consistent with physical distancing standards.



#### Bathroom doors converted to "no-touch":



Trash cans and Kleenex placed in hallways for nose blowing, rather than in the classroom.

Plexiglas dividers are placed on teacher desks where and when appropriate.

U-shaped Plexiglas on student desks where 6ft distancing is not always possible.

Teacher desk is 6ft away from student desks. Marked off by tape on the floor.

### Prevention Strategies: Ventilation

#### **Ventilation:**

- ☐ Teachers are asked to keep doors and windows open as much as possible throughput the day.
- Facilities are cleaned each night after students are no longer on campus.
- ☐ Air-conditioning systems have recently been serviced.
- Outdoor instruction is encouraged whenever possible.

\*\*Staff and teachers must keep in mind that opening windows and doors would pose a health or safety risk to individuals using the facility (e.g., allowing in pollen or smoke or exacerbating asthma symptoms). If opening windows poses a safety or health risk, maximize central air filtration for HVAC systems



#### **STUDENTS**

Age	Face Covering Requirement
Under 2 years old	No
2 years old – 2 <sup>nd</sup> grade	Strongly encouraged**
3 <sup>rd</sup> grade – High School	Yes, unless exempt

- \*\*Face coverings are strongly encouraged for young children between two years old and second grade, if they can be worn properly.
- □ A face shield is an acceptable alternative for children in this cohort who cannot wear them properly.
- Persons younger than two years old, anyone who has trouble breathing, anyone who is unconscious or incapacitated, and anyone who is otherwise unable to remove the face covering without assistance are exempt from wearing a face covering.
- A cloth face covering or face shield should be removed for meals, snacks, naptime, or outdoor recreation, or when it needs to be replaced. When a cloth face covering is temporarily removed, it should be placed in a clean paper bag (marked with the student's name and date) until it needs to be put on again.
- In order to comply with this guidance, schools must exclude students from campus if they are not exempt from wearing a face covering under CDPH guidelines and refuse to wear one provided by the school. Schools should develop protocols to provide a face covering to students who inadvertently fail to bring a face covering to school to prevent unnecessary exclusions. Schools should offer alternative educational opportunities for students who are excluded from campus.

#### <u>Staff</u>

- □ All staff must use face coverings in accordance with CDPH guidelines unless Cal/OSHA standards require respiratory protection.
- ☐ Face **shields are not an acceptable alternative to face coverings unless** the face shield has an appropriate seal (cloth covering extending from the bottom edge of the shield and tucked into the shirt collar).
- ☐ Face coverings with a clear panel are also acceptable for phonological instruction or for use with students w/ special needs.
- Workers or other persons handling or serving food must use gloves in addition to face coverings. Employers should consider where disposable glove use may be helpful to supplement frequent handwashing or use of hand sanitizer; examples are for workers who are screening others for symptoms or handling commonly touched items.

#### **Face Covers**

- 1. Teachers and staff:
  - ☐ All adults must wear a cloth face covering at all times while on campus, except while eating or drinking.
- 2. Students: All students (kindergarten through 10th grade) are required to wear cloth face coverings:
  - while arriving and departing from school campus;
  - in any area outside of the classroom (except when eating, drinking, during recess (Elementary students only) or engaging in physical activity)
  - \*\*Cloth face coverings must be worn **during indoor physical conditioning and training or physical education classes**. Activities that require heavy exertion should be conducted outside in a physically distanced manner without face coverings. Activities conducted inside should be those that do not require heavy exertion and can be done with a face covering. Students should take a break from exercise if any difficulty in breathing is noted and should change their face covering if it becomes wet and sticks to the student's face and obstructs breathing.
- 3. Students/staff **excluded** from face covering requirements include:
- Anyone who has **trouble breathing** or is unconscious, incapacitated, or otherwise unable to remove the covering without assistance
- □ Staff will not be allowed to have direct contact with students if they are unable to wear a face covering.
- □ Students with **special needs** who are unable to tolerate a face covering. **Contact Lizette if this is the case.**

#### **Face Covers**

- **Elementary** students in grades K-2 are **encouraged**, but are not required, to wear a cloth face covering within their stable classroom cohort. A face shield is an acceptable alternative for children in this cohort who cannot wear masks properly.
- Elementary students in grades 3-5, middle school and high school students must use cloth face coverings when in the classroom.

- ☐ Hang used masks on "desk hook in a labeled brown bag"-Elementary School Only
- If elementary students are outside the classroom where they are only with members of their stable cohort, cloth face coverings are not required.

#### **Face Covers- Teachers ONLY**

Face shields are **not recommended as a replacement for face coverings** given concerns over their ability to minimize droplet spread to others. Teachers may consider using face shields with an appropriate seal (cloth covering extending from the bottom edge of the shield and tucked into the shirt collar) in certain limited situations: during phonological instruction to enable students to see the teacher's mouth and in settings where a cloth face covering poses a barrier to communicating with a student who is hearing impaired or a student with a disability.

Teachers are encouraged to wear masks and face shields when in the classroom, to minimize exposure risk.

#### **Face Covers**

- If a student arrives at school without a face mask, he/she will be asked to go to the office to obtain one before entering the classroom. (Middle & High school)
- Students without face coverings should maintain physical distance to the extent feasible. (Elementary ONLY)
- If a student experiences difficulty wearing his/her face covering, the individual will be allowed to remove his/her face covering for a short period of time. If a student needs a break from wearing the mask, they may be given permission to step out for a few minutes or walk to the restroom. (Middle & High School)
- Teachers may use face shields with an appropriate seal during phonological instruction to enable students to see the teacher's mouth and in settings where a cloth face covering poses a barrier to communicating with a student who is hearing impaired or a student with a disability.
- □ Students and staff should be frequently reminded **not to touch the face covering and to wash their hands frequently**.

Fire drills will be suspended until further notice. Teachers will talk about fire drill procedures in the classroom.

**Group/partner** work should be done with the same group/partner.

#### **Elementary School**

A HyFlex option will be available to those students who are at high-risk, or for those families who do not feel comfortable with sending their student(s) to
school. These families can choose distance learning through live, synchronous instruction with teachers. Cameras will be placed in classrooms for live lesson
capturing.
Students and staff will remain in stable classroom cohorts by keeping the same students and teacher or staff together for the entire school day, with the
exception of co-curricular teachers.
Students will not mix with other stable classroom cohorts, to the extend possible.
Teacher and staff desks will be at least six feet away from students to minimize adult-to-child disease transmission.
Stable seating arrangements for students will be assigned to ensure that close contacts within classrooms are minimized and easily identifiable.
Stable classroom cohorts will take priority over physical distancing or face covering use.
Students will be spaced as much as possible.
Suspend carpet time activities, unless spacing between students can be ensured
Student belongings will be kept separate so that students do not come in contact with other students' belongings.
Students will be discouraged to bring materials to and from school. Essentials will remain at school to limit cross- contamination.
Live lesson streaming will be available to those students who are at high-risk, or for those families who do not feel comfortable with sending their student(s)
to school. Parents of these students can choose distance learning through live synchronous instruction with teachers.
Use <b>non-classroom space</b> (outdoors, gym) for instruction, when possible and feasible.
Lockdown and earth quake drills will be performed with physical distancing guidelines in mind.

**Group/partner** work should be done with the same group/partner.

#### Middle School (6<sup>th</sup> grade)

A HyFlex option will be available to those students who are at high-risk, or for those families who do not feel comfortable with sending their
student(s) to school. These families can choose distance learning through live, synchronous instruction with teachers. Cameras will be place
in classrooms for live lesson capturing.
100% online learning will only take place if an all-school closure is ordered by the state or the county.
Students will be spaced at least six feet apart, as far as possible. At the very least- maximize the space between students' desks/seats.
Stable seating arrangements for students will be assigned to ensure that close contacts within classrooms are minimized and easily identifiab
Teacher and staff desks will be at least six feet away from students to minimize adult-to-child disease transmission.
Stable classroom cohorts will be facilitated by having different teachers rotate into the classroom to teach different subjects, with the
exception of some science classes, some math classes & electives.
Live lesson streaming will be available to those students who are at high-risk, or for those families who do not feel comfortable with sending
their student(s) to school. Parents of these students can choose distance learning through live synchronous instruction with teachers.
Use <b>non-classroom space</b> (outdoors, gym) for instruction, when possible and feasible.
Lockdown and earth quake drills will be performed with physical distancing guidelines in mind.
Fire drills will be suspended until further notice. Teachers will talk about fire drill procedures in the classroom.

#### **Co-Curriculars**

- Students will be spaced at least six feet apart, as far as possible. At the very least- maximize the space between students' desks/seats. Plexiglas barriers will be available in the Computer Lab and Art room.
- **Stable seating arrangements** for students will be assigned to ensure that close contacts within classrooms are minimized and easily identifiable.
- ☐ Teacher and staff desks will be at least six feet away from students to minimize adult-to-child disease transmission.
- □ Stable classroom cohorts will be facilitated by not having general education and LAD students mix (Elementary ONLY)
- □ **Live lesson streaming** will be available to those students who are at high-risk, or for those families who do not feel comfortable with sending their student(s) to school. Parents of these students can choose distance learning through live synchronous instruction with teachers.
- ☐ Use **non-classroom space** (outdoors, gym) for instruction, whenever possible.

#### **Limit Sharing**

- Each child's belongings will be kept separated and in individually labeled storage containers, cubbies or areas.
- □ Students bring in their own supplies. Textbooks and workbooks will not be shared by students.
- Students will bring in their own Art supplies, it will be kept in a sealed container until use- no sharing will be allowed.
- Computer keyboards will be covered by an easy to clean cover between uses.



#### <u>Staff</u>



#### **Hallways**


- Congregated movement through hallways will be minimized as much as practicable.
- Designated entrances and exits.
- ☐ **Staggered** passing times- **Arrange with co- teachers** to leave classrooms 1-2 minutes early/late to avoid bottle necks in the hallways.
- Designated one-way walking/passage areas- only if needed.

#### **Designated Entrances**

- ☐ Main entry to Burkhart: 3LAD, 2<sup>nd</sup> grade, 5LAD, 3<sup>rd</sup> & 4LAD grade **ONLY**
- Downstairs (side) door in Burkhart: 1<sup>st</sup> grade, 1/2LAD ONLY
- ☐ Kinder-Use classroom door to the outside **ONLY**
- ☐ Upstairs door in Burkhart: 5<sup>th</sup> & 4<sup>th</sup> grades **ONLY**
- MS & HS: 6<sup>th</sup> use the stairs closest to Wendy's room











#### **Lower Elementary Recess**

#### **Drop Off**

- ☐ Parents and students remain in their car.
- Parents must turn in student health screening declaration.
- □ Students with **symptoms (not due to another known cause) or a fever of 100** °F will not be admitted to the campus.
- □ Student may **get out of the car** and walk to his/her class' line, once health checks are complete.
- □ Students will **line up with physical** distance between each student. Student will be standing on a marker.
- ☐ Designated routes for entry and exit. See diagram on next page(s).
- □ Parking during school hours (8:00-3:30) will only be allowed in the small, outer parking lot, closest to Magdalena Ave.

#### Pick-Up

- ☐ All students must **remain seated until they are called** to the pick-up area.

#### Drop Off & Pick-Up for Kindergarten & 1st During the first week of on-campus instruction


- □ A single parent or caregiver **will be** allowed on the blacktop in front of Burkhart Hall for a special 8:45 a.m. drop-off.
- ☐ Kindergarten and 1st grade parents will not be allowed on the blacktop before 8:45 a.m.



### **Service Providers**

Only necessary service providers, such as educational professionals and therapists will be allowed on campus.

### **Health Screening for Staff, Students and Campus Visitors**

The questions below must be answered daily.

A person who answers 'Yes" to any of these questions will NOT be allowed to enter the school facility.

- Within the last 14 days have you been diagnosed with COVID -19 or had a test confirming you have this virus?
   Yes- Stay home and seek medical care and testing
- Do you live in the same household, or have you had close contact with someone who in the past 14 days has been in isolation for COVID -19 or had a test confirming they have the virus? Close contact is less than 6ft for 15 minutes or more.

- Have you had any or more of these symptoms today or within the past 3 days?

# **Training and Topics**

Clear, age-appropriate communication about COVID-19 and what to expect when children and youth return to school will occur in advance of school campus reopening. In addition, it will be important that regular updates be provided to children and their parents/caregivers throughout the school year. Since the closure in March, LACS has communicated regularly with updates to the entire school community.

Most required training to start the school year will be done via online platforms. Classes will include COVID-19 Safety Training, Mandated Reporter, and Harassment Prevention. Any additional training will be conducted in spaces where six-foot distancing can be observed. All employees will receive training both virtually and in person to ensure all are educated regarding new COVID safety guidelines. Additionally, signage will be placed across campus and in classrooms as reminders.

Training topics will include: face covering usage, removal and washing, COVID-19 symptom prevention, identification, and minimizing spread, physical distancing, procedures on campus to protect children and adults from contracting the virus, protocol in the case of a positive COVID-19 test, and policies for students and employees when sick. Parents, staff and faculty are also required to read through the school reopening plan. Parents, staff and faculty will be required to sign a document to acknowledge that they have read, they understand and are willing to abide by the school reopening protocols.

Teachers will also dedicate classroom time to cover the following tropic regularly with their students:

- Face covering usage, removal and washing,
- COVID-19 symptom prevention
- Protocols and procedures

All employees, students and volunteers must be self-screened for COVID-19 prior to arriving on campus.

### **Students**

- □ Parents must screen students for COVID-19 symptoms before arriving on campus for school or extra-curricular activities.
   □ Parents must check their child to ensure they are fever free and observe for symptoms as outlined below.
- ☐ Daily parental health screenings will be completed.
- Students must be kept at home if they have symptoms consistent with COVID-19 or if they have had close contact with a person diagnosed with or suspected to have COVID-19. Students who are kept at home will be able to live stream their classes. Students will therefor keep up with their academics.
- Parents must notify the administration if they are keeping their child at home due to potential or confirmed COVID-19 related illness.
- As needed the school will perform **visual wellness checks** and ask all students about COVID-19 symptoms within the last **3 days** and whether anyone in their home has had COVID-19 symptoms or a positive test.
- □ LACS will perform **daily temperature** checks. This will be done, **before the child leaves** his/her car.
- ☐ All staff and employees will be involved in this process to ensure efficiency.
- Students or staff with any identified COVID-19 symptoms and/or a temperature of 100°F or higher will be sent home immediately until testing and/or medical evaluation has been conducted.

## **Employees & Visitors**

- Employees and volunteers should self screen themselves for COVID-19 symptoms before arriving on campus.
- Daily health screenings will be completed on paper, or via an online App.
- Employees should ensure they are fever free, and observe themselves for COVID-19 symptoms as outlined above.
- Employees should **stay home** if they have symptoms consistent with COVID-19 or if they have had close contact with a person diagnosed or suspected to have COVID-19.
- Employees should notify administration immediately if they are staying home due to potential or confirmed COVID-19 related illness.
- As needed the school will perform **temperature checks**, **visual wellness checks and ask all employees and volunteers** about COVID-19 symptoms within the last 3 days and whether anyone in their home has had COVID-19 symptoms or a positive test.
- Students or staff with any identified COVID-19 symptoms and/or a temperature of 100°F or higher will be sent home immediately until testing and/or medical evaluation has been conducted.

## Attendance/Sick Leave Policy- During the Covid-19 Pandemic

In the event an instructional staff member must quarantine due to a sick family member, the instructional staff member may:

- Teach their class(-es) via Zoom video conferencing. If this option is selected, the teacher will provide the instruction and grade the assignments. A substitute will be assigned to the class to monitor students. The cost of a substitute will be covered 100% by the school. Sick leave days will not be deducted from the employee.
- Request a substitute to be hired for the time period needing to be quarantined. The classroom teacher will provide five (5) days of lesson plans and be available to discuss with the substitute instruction, students' progress, etc. In this situation, sick leave days will be deducted and pay will reflect this choice.

# Health Screening for Staff, Students and Campus Visitors

The questions below must be answered daily.

A person who answers 'Yes" to any of these questions will NOT be allowed to enter the school facility.

- ❖ Within the last 14 days have you been diagnosed with COVID -19 or had a test confirming you have this virus?
  - → Yes- Stay home and seek medical care and testing
- Do you live in the same household, or have you had close contact with someone who in the past 14 days has been in isolation for COVID -19 or had a test confirming they have the virus? Close contact is less than 6ft for 15 minutes or more.

# **Absenteeism**

- □ Daily attendance will be taken. Staff and student absenteeism will be recorded and tracked. Reason (symptoms and type of illness) for absence will be recorded. (See attachment)
- The Head of Schools, Mrs. Cathy Robinson will be responsible for the following actions:
- Coordinate the documentation and tracking of possible exposure
- Notify local health officials, staff and families in a prompt and responsible manner
- Require staff and families to self- report symptoms and receive prompt notifications of exposures and closures, while maintaining confidentiality, as required by FERPA and state law related to privacy of educational records.

## **Testing of All Staff and Faculty**

- □ School staff are essential workers, and staff includes teachers, paraprofessionals, cafeteria workers, janitors, bus drivers, or any other school employee that may have contact with students or other staff.
- LACS staff will be tested periodically, as testing capacity permits and as practicable.

All staff will be tested over a ONE month period.

- □ 50% of staff will tested every 2 weeks,
- □ 100% every month to rotate testing of all staff over time

### LACS Staff and Faculty Covid-19 Testing

### Who will pay for the testing of school employees?

School employees would either go to their health care provider or a state-operated or other community testing site. The Department of Managed Health Care has filed an <u>emergency regulation</u> to require health plans to pay for COVID-19 testing for all essential workers, including school staff. In addition, tests are available at <u>community testing sites</u> throughout the state.

# LACS Monitoring Strategies: COVID-19 Testing & Reporting

Students and staff must get tested as soon as possible after they develop one or more COVID-19 symptoms or if one of their household members or non-household close contacts tested positive for COVID-19.

## Positive test results

❖ Parents/guardians **MUST** notify school administration immediately if the student tested positive for COVID-19 or if one of their household members or non-household close contacts tested positive for COVID-19.

# **Negative test results**

- Symptomatic students or staff who test negative for COVID-19 MUST remain home until at least 72 hours after resolution of fever (if any) and improvement in other symptoms.
- ❖ **Asymptomatic non-household** close contacts to a COVID-19 case should remain at home for a total of **14 days** from date of last exposure even if they test negative.
- Asymptomatic household contacts should remain at home until 14 days after the COVID-19 positive household member completes their isolation.
- Documentation of negative test results must be provided to school administration.
- ❖ In lieu of a negative test result, symptomatic students and staff will be allowed to return to work/school with a medical note by a physician that provides an alternative explanation for symptoms and reason for not ordering COVID-19 testing.

Staff, students or visitors at LACS will be transported home or to a healthcare facility, as appropriate, when an individual is exhibiting COVID-19 symptoms:

Fever
Cough
Shortness of breath or difficulty breathing
Chills
Repeated shaking with chills
Fatigue
Muscle pain
Headache
Sore throat

New loss of taste or smell

Nausea or vomitina

Diarrhea

- ✓ LACS has an **isolation room** for **anyone who exhibits COVID-19 symptoms**. This room will exclusively be used for COVID 19 cases. A secondary room will be used to deal with other issues, such as scrapes and bruises.
- ✓ Any students/staff exhibiting symptoms WILL immediately be required to wear a face covering and wait in the "sick room" area until they can be transported home or to a healthcare facility, as soon as practicable.
- √ 911 will be called if COVID-19 symptoms become severe, including persistent pain or pressure in the chest, confusion, or bluish lips or face.



# LACS Response to Suspected or Confirmed Cases and Close Contacts

### **Confirmed COVID-19 Case(s) Response:**

- School administrators will **notify** the County of Santa Clara Public Health Department **immediately of any positive COVID-19 case** by emailing coronavirus@phd.sccgov.org and calling (408) 885-4214.
- ☐ All staff and families in the school community of any positive COVID-19 case will be notified while maintaining confidentiality as required by state and federal laws.
- All areas used by any individual suspected of being infected with the virus that causes COVID-19 will be closed off, and not be used before cleaning and disinfection. To reduce risk of exposure, wait 24 hours before you clean and disinfect. If it is not possible to wait 24 hours, wait as long as practicable.

  Ensure a safe and correct application of disinfectants using personal protective equipment and ventilation recommended for cleaning. Keep disinfectant products away from students.
- For **elementary** schools and other settings in which stable classroom cohorts have been maintained: All students and staff within the same classroom cohort as the confirmed COVID-19 case should be instructed to **get COVID-19 testing around 7 days after the last exposure to the case and remain quarantined at home for 14 days.**
- For **middle and high school**, and any settings in which stable classroom cohorts have NOT been maintained: Utilize class seating rosters and consultation with teachers/staff to identify close contacts to the confirmed COVID-19 case in all classrooms and on-campus activities. A **close contact** is someone who has been within six feet of the case for a prolonged period of time (at least 15 minutes) regardless of face covering use. Close contacts should be instructed to get COVID-19 testing **around 7 days** after the last exposure to the case and should remain quarantined at home for **14 days**.
- For all settings: Provide information regarding close contacts to the County of Santa Clara Public Health Department via secure fax or email.
- No actions need to be taken for persons who have not had close contact with a confirmed COVID-19 case, and instead have had close contact with persons who were in direct contact.

### When to Return to Campus after Testing

### Positive test results

- Symptomatic individuals who test positive for COVID-19 can return at least 10 days since symptoms first appeared AND at least 3 days with no fever AND improvement in other symptoms.
- Asymptomatic individuals who test positive for COVID-19 can return 10 days after their positive test result.

# Negative test results

- Symptomatic individuals, who are not close-contacts and who test negative for COVID-19 can **return 72 hours after resolution** of fever (if any) and improvement in symptoms:
  - Documentation of a **negative test result** should be provided to school administrators.
  - In lieu of a negative test result, allow students and staff to return to work with a medical note by a physician that provides alternative explanation for symptoms and reason for not ordering COVID-19 testing.
- Individuals who are close contacts to confirmed COVID-19 cases, who test negative at least 7 days after exposure, and remain asymptomatic, can return **14 days after** the date of last exposure to the case. If a close contact continues to be exposed to a case during their isolation (e.g. household member), quarantine ends **14 days after the case's isolation period ends.**

### What are the criteria for school closure:

Multiple cases in multiple cohorts at LACS or when at least 5 percent of the total number of teachers/student/staff are cases within a 14-day period, depending on the size and physical layout of the school.

### Reopening for in-person learning, after school closure:

LACS will reopen after 14 days and if the following have occurred:

- Cleaning and disinfection
- Public health investigation
- Consultation with the local public health department

### Communication

Several letter templates have been made available by the Santa Clara County Department of Health, which will be used to communicate to parents, staff and faculty if and when we have a COVID-19 case.

As we look forward to a successful return, the importance of the reliability, efficiency, and accessibility of technology cannot be overstated. As such, LACS has invested heavily in hardware and software solutions. We have worked hard to identify clear priorities which are defined as follows.

- The primary software systems of **RenWeb**, **GSuite and Seesaw** will be used to deliver and manage teaching and learning content. The interface of those systems will be standardized as much as possible to simplify the student and parent interface.
- Zoom will be the exclusive video conferencing system used for teaching and learning. Zoom has an important feature that allows small group break out rooms to allow more effective student engagement and collaboration and will allow small group student work even when members of a small group are accessing the classroom remotely.
- LACS has increased our Internet bandwidth to accommodate the increased demand due to providing remote, live access to classrooms every day.
- Cameras and microphones will be used in every classroom to allow students and teachers to access live classroom activities.
- Lessons will not be recorded. Remote learning students must join classes in real time.
